## **Areas of Expertise**

### Regulatory Investigations

Andrew Katzen is one of the country's foremost regulatory and professional discipline experts and represents individuals and corporate bodies under investigation by bodies such as the SRA, FRC, CQC, GMC and Ofsted.

He has particular expertise representing corporates and individuals facing investigation by the FCA. In over 20 years of practice he has acted in some of FCA's biggest and most high profile cases, representing clients accused of including insider dealing, market manipulation, benchmark manipulation and breaches of FCA principles.

Andrew's experience working across regulatory codes gives him the breadth of vision to apply successful tactics from one discipline to another. He has achieved significant successes representing many different types of professionals including lawyers, accountants, doctors and company directors

Most of Andrew's clients in this practice area remain outside the public domain, however they include:

- A corporate and two directors accused of an unlawful collective investment scheme which the FCA alleged was a Ponzi fraud;
- A corporate insurance intermediary and its managing director accused by the FCA of misselling insurance;
- A corporate financial services firm accused of AML systems and controls concerning an 800 million Euros fraud;
- A solicitor and partner in a well-known London law firm accused by the SRA of misappropriating a large amount of funds from client account;
- A solicitor and partner in an international law firm accused by the SRA of tax evasion.

Andrew is a former committee member of the Association of Regulatory & Disciplinary Lawyers (ARDL), is an active member of the seminar sub-committee and has contributed articles to its bulletin.

### Fraud, Corruption & Bribery

#### Proceeds of Crime

He is expert in both criminal law relating to corporate manslaughter-type allegations, and also the various regulatory charges which can arise from serious workplace accidents.

Andrew works in close collaboration with colleagues in the firm's inquest law team to help guide clients through what can be a highly confusing process, and one in which a clear strategy should be determined from as early as possible.

Key clients in this area include advising the trustees of a care home regarding corporate manslaughter and health and safety offences.
